ARTICLE 1. WHAT DATA DO WE COLLECT?

Housinghub.nl collects the following data: Personal identification information (Name, email address, phone number, etc.) This include any data we acquire via details sent via a form or as a reply.

ARTICLE 2. HOW DO WE COLLECT YOUR DATA?

You directly provide HousingHub.nl with most of the data we collect. We collect data and process data when you: Register online or place an order for any of our products or services. Voluntarily complete a customer survey or provide feedback on any of our message boards or via email. Use or view our website via your browser's cookies.

ARTICLE 3. HOW WILL WE USE YOUR DATA?

If you have agreed to receive marketing, you may always opt out at a later date.
